According to the provisions of the Foreign Trade Policy and Hand Book of Procedure Vol. 1, it is mandatory for the exporter to furnish regular monthly returns/details of his export commodity to the concerned registering authority in accordance with the area of his operation. Members are requested to submit monthly export returns (specimen copy enclosed) to the Council latest by 15th of following month, even in respect of "Nil" exports.

Please note that it is also obligatory on the part of the registered exporters to inform in case of change in ownership, constitution, name or address within a period of one month from the date of such change.
